- 1. School Site Observations and Training Invites by CAC Members
 - Observations: per Cabinet, program visits at school sites is approved. Kelley G. will work with various principals and Randa to get a schedule [started.
 - Trainings: Only CNUSD teachers are allowed to attend.
- 2. Fastbridge
 - Kelley met with Ginger Prewitt on whether parents are informed if their children are at risk in all categories of Fastbridge. Current report is not user friendly. It's not informative even to educators. They are working with the company to come up with a user friendly version for parents and educators.
 - Currently developing a training on looking at Fastbridge results and how it translates into present level data (student progress).
- 3. CNUSD Supporting Inclusive Practices (SIP)
 - Follow up on March co-teaching training 3/7/24 15 people registered continue to encourage more to signup.
 - 3/27 Region 10 conference Danny Daher how to teach inclusion in the classroom 4 people registered as of now.

Parents contact site teacher and principal regarding restraint and seclusion because we really work with our staff to train them to CPI (Crisis Prevention Institute) on proper procedures for restraints as necessary as well as deescalating strategies. If there is still a concern about the staff and the parent has a complaint against the staff, we would advise them to file a uniform complaint through HR.

- 1. **Inclusive Practices** Andrea, Lilia
 - Lilia Is there a procedure for our children in SpEd who are facing disciplinary actions or are called in principal's office and then there is a suspension? Is there some kind of procedure, is there an administrator that is trained on inclusive practices for this population who knows how to address or understand the behaviors that are occurring while the student is being addressed? And how to handle that? What behaviors could happen in high stress situations, repetitive behaviors, questioning a student to investigate an incident and asking yes or no questions and the student has heavy history of ABA practice and a lot of compliance you will now be getting a lot of agreement/admission to things that may possibly not have happened? Do the administrators have a resource Do they a program specialist in. There seems to be a heavy focus on resolution vs being informed or getting down to the truth which usually takes more time. Resolution does not take a lot of time.
 - Kelley G. Admin can reach out to their program specialist or other SpEd administrators, case carriers. I hope that consistency would happen regardless of what environment the student is in - more restrictive still using appropriate practices to understand the antecedents/what prompted that behavior, looking at if we have a BIP/FBA, using all those things. This is the SpEd message to all administrators.
 - Lilia need to look at functions of behavior, what is the truth, what actually happened v the resolution within an hour. That doesn't happen that quickly especially with children who have a lot of conditioned behavior.
 - Kelley G School psychologists should be a go to for this, paraeducators to reach out to case carriers.
 - Lilia suspension can be very reinforcing. Escape, maintain behavior. Is suspension really the right path for our children. I want to know how the admin is supported
 - Kelley G. There are discipline guidelines in place, supports such as psychologists, case carriers, program specialists, SpEd admin. Lot of conversations around discipline.
